**Curbside Recycling:**

We provide our customers with four (4) stackable recycling bins for curbside collection of glass (food and beverage containers only), tin and aluminum cans, newspaper, mixed paper and plastic containers (embossed with the insignia #1 or #2 only). These items are picked up for a small fee every other week on the same day as your garbage.

**Garbage Can Size:** Selecting the correct size is important. A standard can is 32-gallons and a mini can is 20-gallons. We offer weekly, every-other-week, or once-a-month service – be sure your can(s) and recycling containers are at curbside by 7:00 a.m.! The weight limit for the standard 32-gallon can is 65 lbs. Keep in mind, overfilled or overweight cans, additional bags, boxes, etc. will cost extra. Be sure to select the number of cans that meets your needs and give **recycling** a chance to work for **YOU!**

**Payment Options:** You may pay by mail with check, money order, or a credit card payment can be made by phone or through our website. For our

**\*\*\*NOTE\*\*\***

Our drivers work all holidays except Thanksgiving Day, Christmas Day and New Year's Day. Following **these Holidays**, if they fall on a weekday, pickup will be **one day late** for the remainder of the week.

**Inclement Weather:** If we are unable to provide service due to weather and/or road conditions your driver will take extra bags/cans on your next regularly scheduled pick up equivalent to your missed service at no additional charge. **No credit will be issued** for missed pick up due to inclement weather. Please call our office to confirm if your service was delayed due to weather.

**Hazardous Waste Fee:** All King County residents pay a Hazardous Waste Fee on their garbage bill. This fee helps fund the Local Hazardous Waste Management Program which provides the services to help educate residents and businesses throughout King County regarding hazardous waste. Some of these services include hazardous waste collection sites and events, education via school programs and community outreach, and free on-site assistance on how to properly store and dispose of hazardous materials.
